

RESOLUTION OF INTENTION NO. 223237 (R.79-1598)

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS OF THE STREET VACATION ACT OF 1941, DECLARING THE INTENTION OF THE CITY COUNCIL TO VACATE A PORTION OF GROVE STREET AND THE ALLEY RUNNING EAST AND WEST, ALL IN BLOCK 5, J. P. CHRISTENSEN'S ADDITION MAP 1054 AND FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego, that the public interest and convenience of said City require the vacation of a portion of the street and alley hereinafter mentioned; and in connection therewith require the reservation of certain easements for a portion of Grove Street and the Alley running east and west, all in Block 5, J. P. Christensen's Addition Map 1054 in the area covered by such street.

BE IT FURTHER RESOLVED, that it is the intention of said Council to order the vacation of a portion of Grove Street and the Alley running east and west, all in Block 5, J. P. Christensen's Addition Map 1054, as more particularly shown on Drawing No. 14554-B on file in the office of the City Clerk as Document No. 766033.


The Council hereby elects to proceed, in making said vacation, under the provisions of the "Street Vacation Act of 1941."

The Council hereby fixes 2:00 P.M. MAY 15 1979 in the Council Chambers on the twelfth floor of the City Administration Building, Charles C. Dail Concourse, 202 "C" Street, in said City of San Diego, as the time and place for hearing all persons interested in or objecting to the proposed vacation.
