WHEREAS, the Planning Department has submitted the above mentioned document and an update report on the process to the City Council Rules Committee for consideration, and the Rules Committee has reviewed this material and found it appropriate with respect to implementing the Coastal Act; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:


That the City Council formally reaffirms the submission to the San Diego Coast Regional Commission of the Tia Juana River Valley Plan as the land use portion of the Local Coastal program for Coastal Commission Certification. Said document is on file in the office of the City Clerk as Document No. 766123.
