
WHEREAS, in Executive Session on March 27, 1979, the APR 17 1979

5, 6, 7, 8 and Mayor Wilson; excused: District 3, approved  
the following; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

That the City Manager be and he is hereby authorized and  
empowered to pay the sum of \$130,000 in settlement of each and  
every claim resulting from the contractual obligations incurred  
as a result of an agreement between Stadium Advertising of  
San Diego, Inc. and The City of San Diego, said sum to be paid  
to Stadium Advertising of San Diego, Inc. and its attorneys,  
Joseph W. Bryans and David G. Burney, in full settlement of all  
obligations in satisfaction of all complaints and cross-complaints  
remaining in the case of Stadium Advertising of San Diego, Inc. v.  
The City of San Diego, San Diego Federal, PSA, Bank of America  
and Union Oil Company, No. 371169.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller  
be and he is hereby authorized to issue a warrant check in the  
amount of \$130,000 to Stadium Advertising of San Diego, Inc.,  
Joseph W. Bryans and David G. Burney, its attorneys, said funds  
to be payable from Unallocated Reserve General Fund 100.


