- 4. That the City Auditor and Comptroller is hereby authorized to transfer the sum of \$358.724 from Gas Tax Funds (CIP No. 52-239) to Gas Tax Reserve Funds (CIP No. 90-220) for the above purpose.
- 5. That this City Council consents to a County Board of Supervisors' resolution, adopted November 21, 1978, declaring

that portion of Mission Gorge Road between the east end of Friars Road Bridge Crossing to the Zion Avenue intersection, and between Princess View Drive to the north end of Father Junipero Serra Trail, a total distance of approximately 1.80 miles, lying within the limits of the City of San Diego, to be a County highway for purposes of acquisition of right-of-way, construction, maintenance, improvement and repair.
