

RESOLUTION NO. 223276

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

1. That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with the COUNTY OF SAN DIEGO for engineering design and contract administration associated with the Recap of Portions of Mission Gorge Road (CIP No. 52-239), under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. 766140.

2. That the expenditure of \$25,000 from Capital Outlay Funds (CIP No. 52-239) and \$104,276 from Gas Tax Funds (CIP No. 52-239) is hereby authorized, solely and exclusively for the above purpose and related costs.

3. That the City Manager be and he is hereby authorized and empowered to do by City Forces all necessary work in conjunction with the Recap of Portions of Mission Gorge Road at the cost of \$14,300, pursuant to the recommendation of the City Manager and the submission of his estimates indicating that said work can be done more economically by City Forces than if let by contract.

4. That the City Auditor and Comptroller is hereby authorized to transfer the sum of \$358,724 from Gas Tax Funds (CIP No. 52-239) to Gas Tax Reserve Funds (CIP No. 90-220) for the above purpose.


5. That this City Council consents to a County Board of Supervisors' resolution, adopted November 21, 1978, declaring

that portion of Mission Gorge Road between the east end of Friars Road Bridge Crossing to the Zion Avenue intersection, and between Princess View Drive to the north end of Father Junipero Serra Trail, a total distance of approximately 1.80 miles, lying within the limits of the City of San Diego, to be a County highway for purposes of acquisition of right-of-way, construction, maintenance, improvement and repair.
