BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a month-to-month Lease Agreement with JULIUS VACVAL, dba, THE CHICKEN ROOST, for the purposes of operating and maintaining the premises of a cafe and amusement arcade for the benefit of the citizens of San Diego and their visitors and for such other related or incidental purposes as may first be approved in writing by the City and for no other purpose, for a term of not to exceed two years, at a monthly rental of \$200, under the terms and conditions set forth in that Lease Agreement on file in the office of the City Clerk as Document No. 766250.
