

RESOLUTION No. 223327 (R-79-2007)

Adopted on APR 23 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the contract with KAISER FOUNDATION HEALTH PLAN, INC. and CITYMED PLAN is hereby amended to provide coverage for obstetrical care in the same manner as coverage for other conditions provided under the health benefit plans, and increasing the monthly rates as follows effective May 1, 1979:
