

RESOLUTION NO. 223335Adopted on APR 24 1979

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Nolan Howard	Water Utilities	\$95	Mr. Howard is an Equipment Technician II in the Systems Division. He developed an air release valve for pumps that will provide an outlet when pumps fail. This saves \$934 annually.
Susan M. Gonzales	Park and Recreation	\$90	Ms. Gonzales is a Gardener in the Parks Division. She suggested that the procedure for emptying trash barrels at the Blacks Beach glider port be simplified. This saves both time and materials. Estimated savings are \$1,779 annually. This is a partial award pending a final 12-month review.
J. Anthony Dickens	General Services	\$90	Mr. Dickens was an Equipment Repair Supervisor in the Equipment Division at the time of his suggestion. He suggested that a portable platform be fabricated to transport packer ejector blades. This saves \$887 annually.
Ronald H. McCleary James D. Cole	General Services	\$85	Mr. McCleary is a Utility Worker II, and Mr. Cole is a Utility Worker I in the Street Division. One year ago they earned a \$75 award for their suggestion to purchase and use a de-burring tool for sign production. One year's experience has shown a total savings of \$1,602. This is the remainder of their award.
Budd Q. Neel	General Services	\$70	Mr. Neel was a Principal Supervisor in the Solid Waste Division at the time of his suggestion. One year ago he earned a \$50 award for his suggestion to have personnel maintain their own uniforms in the Solid Waste Division. Although this is no longer being done, the actual savings while in effect were \$1,194. This is the remainder of his award.
