

RESOLUTION NO. 223336Adopted on APR 24 1979

WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

| <u>NAME</u> | <u>DEPARTMENT</u> | <u>AMOUNT</u> | <u>SUGGESTION</u> |
|------------------------------|-----------------------------|---------------|---|
| Carmen C. Lutes | Engineering and Development | \$65 | Ms. Lutes was an Intermediate Stenographer at the time of her suggestion. One year ago she earned a \$65 award for her suggestion to increase the size of three forms from letter size to legal size to reduce microfilm costs. One year's experience has shown a savings of \$1,300. This is the remainder of her award. |
| Phillip J. Love | General Services | \$60 | Mr. Love is a Carpenter Supervisor in the Buildings Division. He suggested that clear break proof score board covers be used for score boards. This drastically reduces repairs and is expected to save \$608 annually. |
| William Stanley Nolan Howard | Water Utilities | \$55 | Mr. Stanley and Mr. Howard are Equipment Technicians II in the Systems Division. They suggested that an overhead rail be installed at Pump Station 9. This will make pump servicing much simpler. This saves \$552 annually. |
| David G. Kemp | Engineering and Development | \$55 | Mr. Kemp was an Assistant Civil Engineer at the time of his suggestion. One year ago he earned a \$340 award with his suggestion to develop an input editing feature for the Floodplain and Beach Erosion Program. One year's experience has shown a total savings of \$3,960. This is the remainder of his award. |
| Elvin W. Allen | General Services | \$50 | Mr. Allen is an Airports Operations Assistant in the Airports Division. He suggested that the hose carrying fixture on the airport rescue vehicle be modified to shorten response. This was considered to be a significant public safety improvement. |
