WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
William L. Jenkins	General Services	\$45	Mr. Jenkins is a Welder in the Equipment Division. He suggested that a detroit cylinder head lifting tool be fabricated to reduce the time necessary to lift cylinder heads. This saves \$453 annually.
Roy C. Wamback	General Services	\$35	Mr. Wamback is a Custodian II in the Buildings Division. He suggested a method of reducing sand spillage for ash trays. This reduces the time it takes to maintain carpets and saves \$345 annually.
Mortimer F. Christo	Water Utilities	\$20	Mr. Christo is a Plant Operator II in the Quality Division. He suggested that the entrance to Pump Station 1 be reconstructed. This was considered to be a significant safety improvement.
Catherine L. Meyer	Planning	\$20	Ms. Meyer is an Intermediate Stenographer. She suggested that Subdivision Board and Committee agendas be mailed without envelopes. This saves \$190 annually in preparation costs.
Phillip J. Love	General Services	\$20	Mr. Love is a Carpenter Supervisor in the Buildings Division. He suggested that one way lag bolts be used in high security installations. This was considered to be a valuable operational improvement.
George R. Ikeda	General Services	\$20	Mr. Ikeda is a Carpenter in the Buildings Division. He suggested that life jackets be provided for employees working at piers or other aquatic settings. This was considered to be a significant safety improvement.
