Margaret A. Thomas	Risk Management	\$20	Ms. Thomas is a Senior Clerk in the Safety Program. One year ago she suggested that two letters sent to new employees could be typed simultaneously by using a high grade carbon paper. She earned a \$10 award with her idea. One year's experience has shown a savings of \$279. This is the remainder of her award.
Carl C. Murray	General Services	\$20	Mr. Murray is an Equipment Mechanic in the Equipment Division. He developed an adjustor for packer cam plates that reduces cam plate damage. This was considered to be a significant operational improvement.
John M. Fix	General Services	\$20	Mr. Fix is an Equipment Mechanic in the Equipment Division. He suggested that a diesel fuel system trouble shooting test guage be fabricated. This was considered to be a significant operational improvement.
Daniel A. Volk	General Services	\$20	Mr. Volk is an Equipment Mechanic in the Equipment Division. He suggested that power steering pumps be moved on fixed cab trucks for easier maintenance of drive belts. This was considered to be a significant operational improvement.
Catherine L. Meyer	Planning	\$15	Ms. Meyer is an Intermediate Stenographer. She developed a numerical filing system for Subdivision active files. This was considered to be a significant operational improvement.
Catherine L. Meyer	Planning	\$15	Ms. Meyer is an Intermediate Stenographer. She developed disposition sheet for tentative Subdivision maps. This was considered to be a significant operational improvement.
