WHEREAS, the Suggestion Awards Committee has heretofore made certain recommendations to this Council; and

WHEREAS, the Council has reviewed said recommendations as well as the suggestions as presented; NOW THEREFORE,

BE IT RESOLVED, by the Council of the City of San Diego, as follows:

That the following suggestion awards are hereby approved and the Auditor and Comptroller is hereby directed to issue warrants out of the General Fund for the following suggestions:

<u>NAME</u>	<u>DEPARTMENT</u>	<u>AMOUNT</u>	<u>SUGGESTION</u>
Tony C. Zepeda	General Services	\$10	Mr. Zepeda is a Carpenter in the Buildings Division. He suggested that self-drilling anchors be used for swimming pool starting blocks. This reduces repairs and saves \$106 annually.
Roy F. Pletcher	Water Utilities	\$10	Mr. Pletcher is a Plant Operator in the Quality Division. He suggested that 15 horse power compressors be installed in the Carter Gun mixing system at the Pt. Loma Plant. This was considered to be a significant operational improvement.
Carol J. Gollihugh	Citizens Assistance & Public Information	\$10	Ms. Gollihugh is an Intermediate Typist. She suggested that a copy machine be installed in the lobby of the City Administration Building. This was considered to be a significant public service improvement.
Gloria J. Butler	Financial Management	\$10	Ms. Butler is a Program Typewriter Operator. She suggested that both sides of the paper be used when typing drafts of reports and memoranda. This was considered to be a significant conservation idea.
Sally A. Vecchitto	Risk Management	\$10	Ms. Vecchitto is an Intermediate Typist in the Workers' Compensation Program. One year ago Ms. Vecchitto earned a \$10 award for her suggestion to place suggestion numbers on resolutions to decrease the time it takes to process 12-month reviews. One year's experience has shown a savings of \$193. This is the remainder of her award.
