| Howard H. Betts | Water Utilities | \$10 | Mr. Betts is an Engineering Trainee in the Systems Division. He suggested that a collection bin be placed by the copier to recover waste paper. This was considered to be a significant conservation improvement. |
| Val Kisak | Park and Recreation | \$10 | Mr. Kisak is a Recreation Facility Caretaker in the Recreation Division. He suggested that the number of cleaning agents used in the Recreation Division be reduced to save money on orders. This was considered to be a significant operational improvement. |
| Flavian R. Geis | Engineering and Development | \$10 | Mr. Geis was an Intermediate Typist at the time of his suggestion. One year ago he suggested the elimination of the Advance Deposit Invoice Statement Form. He earned a \$75 award at that time. One year's experience has shown a savings of \$863. This is the remainder of his award. |
