(south area B), 120, 121, 246, 425, 428, 455, 592, 593, 595,
596, 597, 599 and 600, as shown on that Document No. 766252,
on file in the office of the City Clerk, are hereby approved.

BE IT FURTHER RESOLVED, that that site numbered 132 is
hereby referred to the Housing Authority and that the matter
of designating a use for that site numbered 594 is hereby
continued to the Council meeting of May 8, 1979 for a report
from the Planning Department.
