

RESOLUTION No. 223362 (R-79-200A)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$149,941.00 by SCHEIDEL CORPORATION, a corporation, for the CONSTRUCTION OF TWO (2) STAIRWAYS AT EAST END OF SAN DIEGO STADIUM, Schedule 1, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 765671.
2. That the City Auditor and Comptroller is hereby authorized to transfer \$150,000.00 from Capital Outlay Fund 245, CIP 22-808, Fiesta Island Utilities, to Capital Outlay Fund 245, CIP 34-021, San Diego Stadium, Permanent Stairways for temporary seating (East End).
3. That the City Auditor and Comptroller is hereby authorized to transfer \$30,000.00 of Transient Occupancy Tax (Fund 223) from CIP 34-030 (Civic Theatre-Purchase of Orchestra Shell) to CIP 34-021 (San Diego Stadium-Permanent Stairways) for temporary seating (East End).
4. That the expenditure of \$181,000.00 is hereby authorized out of Capital Outlay Fund 245 and that the expenditure of \$30,000.00 is hereby authorized out of Transient Occupancy Tax Fund 223 of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.
