BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$52,000.00 by HENRY REDONDO, AN INDIVIDUAL DBA REDONDO ELECTRIC for the CONSTRUCTION OF ALLIED GARDENS COMMUNITY PARK AND PRESIDIO RECREATION CENTER - PARK LIGHTING, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 765702.
2. That the expenditure of \$10,000.00 is hereby authorized from Park Service District Fund 11380 of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$26,100.00 from CIP No. 23-154 and \$78,400.00 from CIP No. 23-276 to Capital Outlay Reserve, CIP No. 90-245.
