

APPROVING MAP OF CAMEO GLEN AND ACKNOWLEDGING RECEIPT **APR 30 1978**  
OF SUBDIVIDER'S ASSURANCE OF COMPLIANCE WITH THE  
AFFIRMATIVE MARKETING PROGRAM.

BE IT RESOLVED, by the Council of The City of San  
Diego, as follows:

Said Council hereby finds that that certain map surveyed  
by M. L. SPLITSTONE, a Registered Civil Engineer, entitled  
"CAMEO GLEN Being a subdivision of Lot 3 of Clairemont  
Park Unit No. 2, Resubdivision No. 1, according to Map No.  
5197, and a portion of Pueblo Lot 1212 of the Pueblo Lands  
of San Diego, according to Map thereof made by James Pascoe  
in 1870, filed November 14, 1921, and known as Miscellaneous  
Map No. 36.", is made in the manner and form prescribed by  
law and conforms to the surrounding surveys; that said map  
and the subdivision of land shown thereon is hereby approved  
and accepted; and said Council hereby accepts on behalf of  
the public, the following: Cameo Lane and Cameo Court for  
public purposes, and said streets are hereby declared to be  
public streets and dedicated to the public use.

BE IT FURTHER RESOLVED, that said Council hereby accepts  
on behalf of The City of San Diego, a municipal corporation,  
any and all abutters' rights of access in and to Cameo Lane,  
adjacent and contiguous to Lots 27 and 28, together with the  
easements with the right of ingress and egress for the  
construction and maintenance of drainage and sewer facilities,  
all as shown on this map within this subdivision.


