Said Council hereby finds that that certain map surveyed by DON NASLAND, a Licensed Land Surveyor, entitled "CANYON RIM Being a subdivision of Lot 2 of View Terrace, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 7054, filed in the office of County Recorder of San Diego County, September 16, 1971.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted.

BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of water facilities, as granted and shown on said map and subject to the conditions set forth thereon.


