WHEREAS, on May 25, 1977, by Resolution No. 218452, the Council of The City of San Diego authorized the payment of \$30,000.00 to the Convention and Visitors Bureau for purposes of contracting for the production of two television specials promoting the City of San Diego; and

WHEREAS, Consolidated Entertainment, Ltd., the company which was to air one of the television specials, obtained a performance bond from a company now known as Indiana National Marketing Corporation, in which bond The City of San Diego was named as obligee; and


WHEREAS, Consolidated Entertainment, Ltd., defaulted in the performance of its agreement to air the television special; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be and he is hereby authorized and empowered to accept on behalf of The City of San Diego \$15,000.00 from Indiana National Marketing Corporation (successor to Indiana Bonding and Surety Company) in settlement of all claims in connection with the above mentioned performance bond; and

BE IT FURTHER RESOLVED, that the City Manager be and he is hereby authorized and empowered to execute on behalf of The City of San Diego a Release and Assignment which will prevent future claims against said Corporation and assign to said Corporation all rights to claims against Consolidated Entertainment, Ltd., a copy of which Release and Assignment is on file in the Office of the City Clerk as Document No. 766412.
