BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$25,000 in Gas Tax Fund 219 from CIP 52-010.2 (Coronado Avenue) to CIP 52-255 (SA-680) to finance the cost of said right-of-way services.
