That the firm of Gray, Cary, Ames and Frye be hereby employed and appointed as Special Bond Counsel in connection with the proposed proceedings under the San Diego Improvement District Procedural Ordinance for the paving and improvement of CAMINO DEL NORTE (SA-680) between I-15 and Pomerado Road pursuant to the terms and conditions set forth in the letter dated February 12, 1979, from Gray, Cary, Ames and Frye, which is on file in the office of the City Clerk as Document No. 766365.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be, and he is hereby authorized to transfer the sum of \$13,000 in Gas Tax Fund 219 from CIP 52-010.2 (Coronado Avenue) to CIP 52-255 (SA-680) for the purpose of retaining said Bond Counsel.




CERTIFICATION OF UNENCUMBERED BALANCE
