

RESOLUTION OF INTENTION NO. 223432

(R.79-1872)

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS **MAY 7 1979**
OF THE STREET VACATION ACT OF 1941, DECLARING THE
INTENTION OF THE CITY COUNCIL TO VACATE STREET
RESERVATION OF SOUTHERLY 28 FEET OF PARCEL 2
OF PARCEL MAP NO. 3663 AND LOTS 2 AND 3 IN BLOCK
12 OF LINDA VISTA UNIT NO. 6, MAP NO. 3135 AND
FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San
Diego, that the public interest and convenience of said City
require the vacation of a portion of the street hereinafter
mentioned; and

BE IT FURTHER RESOLVED, that it is the intention of
said Council to order the vacation of STREET RESERVATION OF
SOUTHERLY 28 FEET OF PARCEL 2 OF PARCEL MAP NO. 3663 AND LOTS
2 AND 3 IN BLOCK 12 OF LINDA VISTA UNIT NO. 6, MAP NO. 3135 as
more particularly shown on Drawing No. 14527-B on file in
the office of the City Clerk as Document No. 766267.

The Council hereby elects to proceed, in making said
vacation, under the provisions of the "Street Vacation Act
of 1941."


The Council hereby fixes 2:00 P.M. JUN 12 1979
