


RESOLUTION No. 223433 (R-79-866)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a Lease Agreement with ZLAC PIER ASSOCIATION, INC., a California nonprofit corporation, for the purpose of operating and maintaining a boat dock for providing promotion of competitive events involving water sports, at an annual rental of \$1,310.00 discounted to \$655.00 per year, for a term of five years, under the terms and conditions set forth in said Lease Agreement on file in the office of the City Clerk as Document No. 766298.
