

RESOLUTION No. 223435 (R-79-1916)

Adopted on MAY 7 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the Auditor and Comptroller be, and he is hereby authorized to transfer \$19,385.92 from 1913 Act Trust Fund 3721 (La Jolla Scenic Drive) to Property Department Revolving Fund 56.50.

2. That the Auditor and Comptroller be, and he is hereby authorized to transfer \$14,612.50 from 1913 Act Trust Fund 3721 to Gas Tax Fund for reimbursement of funds advanced for property acquisition.

3. That the \$13,327.97 remaining in 1913 Act Trust Fund 3721 is hereby declared a surplus.

4. That the City Treasurer is hereby directed to credit said surplus to the various assessees and contributors to the La Jolla Scenic Drive project in accordance with Resolution of Intention No. 217393, adopted December 29, 1976 and the Municipal Improvement Act of 1913 (Sec. 10000 et seq., California Streets and Highways Code).
