

RESOLUTION NO. 223449APPROVING MAP OF TONAWANDA SUBDIVISION

BE IT RESOLVED, by the Council of The City of San Diego,  
as follows:

Said Council hereby finds that that certain map surveyed by FRANK P. PHILLIPS, a Registered Civil Engineer, entitled "TONAWANDA SUBDIVISION UNIT NO. 1 Being a subdivision of a portion of the Northeasterly Quarter of Section 100 of Rancho De La Nacion, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 166 on file in the office of the County Recorder of San Diego County, together with a portion of Tonawanda Drive as dedicated to the public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public a portion of Tonawanda Drive for public purposes, and said portion of a street is hereby declared to be a portion of a public street and dedicated to the public use.


BE IT FURTHER RESOLVED, that said Council hereby accepts on behalf of The City of San Diego, a municipal corporation, the easement with the right of ingress and egress for the construction and maintenance of drainage facilities, as granted and shown on said map and subject to the conditions set forth thereon.
