
BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager is hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a First Amendment to Agreement with COMPONENT HOUSING, INC., for the purpose of constructing one additional single-family residential unit on Parcel #2 of the City-owned Hazelwood Place Extension, under the terms and conditions set forth in that First Amendment to Agreement on file in the office of the City Clerk as Document No. 766361.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized and empowered to proceed with disposition of said residential unit in accordance with the method described in the Manager's Report to the Mayor and City Council dated November, 1978, a copy of which is on file in the office of the City Clerk as Document No. 765214.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$34,612 from the 100 Fund for payments pursuant to the above described contract is hereby authorized and approved.
