

RESOLUTION No. 223491 (R-79-2144)


Adopted on MAY 15 1979 (REV.)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the acceptance by the City Manager of that Street and Drainage easement deed, executed in favor of The City of San Diego, bearing date of March 27, 1979, conveying to said City an easement for the purpose of a right of way for a public street and incidents thereto conveyed as Parcel No. 2, together with an easement for the purpose of a right of way for the construction, operation and maintenance of a storm drain and appurtenances thereto conveyed as Parcel No. 3 in that portion of the East Half Pueblo Lot 1301 of the Pueblo Lands of San Diego, as more particularly described in said deed, be and the same is hereby approved, and the land therein conveyed as Parcel No. 2 is hereby dedicated as and for a public street and the same is hereby named REGENTS ROAD.

BE IT FURTHER RESOLVED, that the City Clerk is hereby authorized and directed to deliver said deed and a certified copy of this resolution to the Engineering and Development Department for further handling.
