

RESOLUTION OF INTENTION NO. 220193 (R.79-1949)

A RESOLUTION ELECTING TO PROCEED UNDER THE PROVISIONS MAY 15 1979
OF THE STREET VACATION ACT OF 1941, DECLARING THE
INTENTION OF THE CITY COUNCIL TO VACATE STREET
RESERVATION - PORTION OF LOT 2, MAP 4299, AND
FIXING A TIME AND PLACE FOR HEARING THEREOF.

BE IT RESOLVED, by the Council of The City of San Diego,
that the public interest and convenience of said City require
the vacation of Street Reservation - portion of Lot 2, Map 4299,
hereinafter mentioned; and

BE IT FURTHER RESOLVED, that it is the intention of said
Council to order the vacation of Street Reservation - portion
of Lot 2, Map 4299, as more particularly shown on Drawing No.
14607-B on file in the office of the City Clerk as Document
No. 766338.

The Council hereby elects to proceed, in making said
vacation, under the provisions of the "Street Vacation Act
of 1941."


The Council hereby fixes 2:00 P.M. JUN 19 1979
