That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, a First Amendment to Agreement with the SAN DIEGO CITY AND COUNTY WAR AGAINST LITTER COMMITTEE, to extend the term of agreement to August 31, 1981, and change the current fiscal year to August 1, 1978 - August 31, 1979, and remaining fiscal years to September 1 - August 31 of each year, under the terms and conditions set forth in the First Amendment to Agreement on file in the office of the City Clerk as Document No. 766527.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller be and he is hereby authorized to transfer the sum of \$7,200 within the Transient Occupancy Tax Unappropriated Reserve Fund (224) from Program Element 52.99 Contingency Reserve to Program Element 52.31 (San Diego War Against Litter Committee), to be used solely and exclusively for the above purpose.
