BE IT FURTHER RESOLVED, that the City Manager is hereby directed to negotiate and execute a First Amendment to Agreement between The City of San Diego and the SAN DIEGO CONVENTION AND VISITORS' BUREAU, on file in the office of the City Clerk as Document No. 766459 in connection with said pilot program.

BE IT FURTHER RESOLVED, that the expenditure of \$9,000 from Transient Occupancy Tax Fund 223 Program Element 5229 and \$3,000 from Transient Occupancy Tax Fund 224 Program Element 5299 is hereby authorized, solely and exclusively for the above purpose.
