

RESOLUTION NO. 223534 (R. 79-2258) MAY 21 1979

WHEREAS, The City of San Diego, a municipal corporation, is the owner in fee of a parcel of land identified as portions of Pueblo Lots 1330, 1333, 1334 and 1361 of Pueblo Lands of San Diego, in the City of San Diego, County of San Diego, State of California, according to Map thereof made by James Pascoe in 1870, on file in the office of the County Recorder of San Diego County and known as Miscellaneous Map No. 36; and


WHEREAS, said City proposes to file a subdivision map of said area to be known as TORREY PINES SCIENCE PARK UNIT 3; and
