That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with WOODWARD-CLYDE CONSULTANTS for an amount not to exceed \$26,500 to provide preliminary plans, specifications and estimate and related services for the shoreline protection and upper cliff stabilization of Sunset Cliffs, said agreement is on file in the office of the City Clerk as Document No. 766649.

BE IT FURTHER RESOLVED, that the expenditure of \$30,000 out of Flood Control and Storm Drain Bond Fund 727 be hereby authorized, solely and exclusively, for the above stated purpose and related project costs.
