

RESOLUTION NO. 223559

WHEREAS, the Law Enforcement Assistance Administration may consent to review for possible funding the project submitted by The City of San Diego referred to as the "Integrated Victim/Witness Assistance Project," on file in the office of the City Clerk as Document No. 766449; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That the City Manager be and he is hereby authorized, for and on behalf of said City, to submit to the Law Enforcement Assistance Administration (LEAA) the application for grant for law enforcement purposes.

BE IT FURTHER RESOLVED, that in the event LEAA consents to fund the above project, The City of San Diego agrees to accept the grant and designates the City Manager to execute, for and on behalf of said City, the contract for the grant for law enforcement purposes, including any extensions or amendments thereof, that do not require any additional appropriation of cash match.

BE IT FURTHER RESOLVED, that the City Manager is authorized without further Council action to go to bid (when necessary) and to negotiate and execute contracts for consultant services, lease or rental services, equipment purchases, and all other related contracts and agreements specified in the grant contract (including any extension or amendment thereof).


BE IT FURTHER RESOLVED, that the City Manager is directed to include \$25,000 in the Fiscal Year 1980 Budget and \$3,136 in the Fiscal Year 1981 Budget from General Revenue Sharing Funds for a total of \$28,136, to provide the required matching funds as set forth in the grant contract.

BE IT FURTHER RESOLVED, that expenditure of the above \$25,000 is authorized to be expended contingent upon approval of the Fiscal Year 1980 Budget.

BE IT FURTHER RESOLVED, that grant funds received hereunder shall not be used to supplant ongoing law enforcement expenditures.
