BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the plans and specifications for the furnishing of all labor, material, tools, equipment, transportation and other expense necessary or incidental for

IMPROVEMENT OF NORTH HARBOR DRIVE FROM 400 FEET EAST OF ESTUARY BRIDGE TO 300

FEET WEST OF NIMITZ BOULEVARD, San Diego, California

filed in the office of the City Clerk of the City of San Diego, California, on MAY 14 1979, and bearing official Document No. 766316, be, and the same are hereby approved.

BE IT FURTHER RESOLVED, that the Council has ascertained the current or prevailing rate of per diem wages paid by private employers in the City for each craft or type of workman or mechanic needed to execute the contract, and does hereby declare that the wage scale included in said specifications is the said current or prevailing rate for the various crafts therein mentioned.

BE IT FURTHER RESOLVED, that the Purchasing Agent of the City of San Diego be, and he is hereby authorized and directed to proceed to publish in accordance with law, notice to contractors calling for bids for the work hereinabove described, in accordance with the plans and specifications hereinabove referred to.

BE IT FURTHER RESOLVED, that the City Manager is hereby authorized to execute a contract with the lowest responsible and reliable bidder for

IMPROVEMENT OF NORTH HARBOR DRIVE FROM 400 FEET EAST OF ESTUARY BRIDGE TO

300 FEET WEST OF NIMITZ BOULEVARD

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer an amount not to exceed \$100,000.00 from Capital Outlay Fund 245, CIP 58-013, Rose Canyon Bikeway, and \$103,600.00 from Capital Outlay Fund 245, CIP 58-014, Rose Creek Bikeway, to Capital Outlay Fund 245, CIP 52-086.5, North Harbor Drive - Nimitz Boulevard to Navy Estuary.

BE IT FURTHER RESOLVED, that the expenditure, not to exceed \$976,600 from Capital Outlay Fund 245 and Gas Tax Fund 220, CIP 52-086.5, -North Harbor Drive - Nimitz Boulevard to Navy Estuary of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs, and authorizing the Auditor and Comptroller, upon advice from the administering department, to transfer excess budgeted funds, if any, to the appropriate reserves.
