That the City Manager be and he is hereby authorized and empowered to execute, for and on behalf of said City, an agreement with CHAPTER TWO--DISABLED AMERICAN VETERANS for the purpose of conducting an event known as VIETNAM VETERANS' WEEK to be held May 28-June 3, 1979, under the terms and conditions set forth in the agreement on file in the office of the City Clerk as Document No. 766477.

BE IT FURTHER RESOLVED, that the expenditure in the sum of \$1,200 from the Transient Occupancy Tax Unappropriated Reserve Fund (224) Contingency Reserve is hereby authorized for the above purpose.

BE IT FURTHER RESOLVED, that the City Auditor and Comptroller is hereby authorized to transfer a sum not to exceed \$1,450 from the Transient Occupancy Tax Unappropriated Reserve Fund (224) Contingency Reserve to the Convention and Performing Arts Center Fund (254), to be used solely and exclusively for the purpose of providing funds for activities in observance of Vietnam Veterans' Week.
