Whereas, the consumer cost of housing units in the City has increased substantially in recent years; and

Whereas, the cost of housing units in the City is impacted by the governmental development regulations; and


Whereas, attitudinal concern has been raised by the Building Industry and by the City's Housing Consultant; and

Whereas, Pursuant to the Housing Consultant's Report to the Housing Authority dated April 23, 1979, it was recommended that the City Council consider issuing a statement enunciating a policy of cooperation with the Building Industry within the framework of sound land use practices; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

That it is the policy of the City of San Diego to minimize the consumer cost of housing in San Diego by minimizing the fiscal impact of governmental regulations pertaining to housing and by encouraging the development of housing units consistent with the City's General Plan, Growth Management Strategy and ability to provide facilities and services.
