

BE IT RESOLVED, by the Council of The City of San Diego, as follows:

1. That the Mayor and the City Clerk are hereby authorized and empowered to execute, for and on behalf of The City of San Diego, a quitclaim deed, which is on file in the office of the City Clerk as Document No. 766427, quitclaiming to A. E. Realty Partners, a general partnership, all the City's right, title and interest in the sewer easement, as more particularly described in said form of quitclaim deed.
