APPROVING MAP OF SOMERSET VIEW UNIT NO. 3 AND
ACKNOWLEDGING RECEIPT OF SUBDIVIDER'S ASSURANCE
OF COMPLIANCE WITH THE AFFIRMATIVE MARKETING
PROGRAM.

BE IT RESOLVED, by the Council of The City of San Diego,
as follows:

Said Council hereby finds that that certain map surveyed by E. F. COOK, a Registered Civil Engineer, entitled "SOMERSET VIEW UNIT NO. 3 Being a subdivision of portions of Lot 7 and 9 of Cave and McHatton Subdivision, in the City of San Diego, County of San Diego, State of California, according to Map thereof No. 159 filed in the office of the County Recorder of San Diego County March 30, 1887, together with a portion of Valencia Parkway (formerly 59th Street) as closed and vacated to public use and together with a portion of Valencia Parkway (formerly 59th Street) as dedicated to public use.", is made in the manner and form prescribed by law and conforms to the surrounding surveys; that said map and the subdivision of land shown thereon is hereby approved and accepted; and said Council hereby accepts on behalf of the public Parkmead Court and a portion of Valencia Parkway for public purposes; and said street and portion of a street are hereby declared to be a public street and portion of a public street and dedicated to the public use.

The Clerk of said City is hereby authorized and directed to endorse upon said map, as and for the act of the Council, that said Council has approved said subdivision map and that said street and portion of a street are accepted on behalf of the public as heretofore stated.


