

FREILICH AND ASSOCIATES, for the purpose of providing consulting and legal services for the City's General Plan and Growth Management Program, for a term of 18 months beginning June 1, 1979, under the terms and conditions set forth in said agreement, a copy of which is on file in the office of the City Clerk as Document No. 766482.

BE IT FURTHER RESOLVED, that the expenditure of not to exceed \$66,000 from the General Fund unallocated Reserve 100, for said services is hereby authorized.


