That the City Auditor and Comptroller be, and he is hereby authorized and empowered to transfer the sum of \$17,628 from CIP No. 90-245, Capital Outlay Fund 245 Unallocated Reserve to CIP No. 58-002 Capital Outlay Fund 245, Special Assessment District.

BE IT FURTHER RESOLVED, that the expenditure of \$93,646 from Capital Outlay Fund 245 of The City of San Diego is hereby authorized, solely and exclusively, for the City's contribution and related costs for the CONSTRUCTION OF SORRENTO VALLEY ROAD PIPELINE under the Improvement Act of 1911.




