


RESOLUTION No. 223634 (R-79-2337)

BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the low acceptable bid and the low bid of OSTERBAUER COMPRESSOR SERVICE is hereby accepted; and the City Manager is hereby authorized to execute a contract for the purchase of FIVE (5) SKID MOUNTED AIR COMPRESSORS at a cost of \$7,535.50 each for a cost of \$37,677.50 and TWO (2) TRAILER MOUNTED AIR COMPRESSORS at a cost of \$7,797.00 each for a cost of \$15,594.00; total cost of \$53,271.50; terms net 30 days, plus sales tax.
