BE IT RESOLVED, by the Council of The City of San Diego as follows:



FLOE for LEADERSHIP HOUSING SYSTEMS, INC., as subdivider.

BE IT FURTHER RESOLVED, that the public improvements to be constructed pursuant to the aforementioned subdivision agreement shall be completed by March 1, 1980, as provided by the amendment to the subdivision agreement.

BE IT FURTHER RESOLVED, that Performance Bond No. 59 61 998, issued by Fidelity and Deposit Company of Maryland in the sum of \$21,902.00, is hereby accepted as the surety for the required improvements in said subdivision, and that Performance Bond No. 09 2122, in the amount of \$21,902.00, issued by Argonaut Insurance Company, is hereby released.
