

**RESOLUTION No.** 223649 (R-79-2351)



BE IT RESOLVED, by the Council of The City of San Diego as follows:

1. That the bid of \$481,311.46 by METRO YOUNG CONSTRUCTION CO., A DIVISION OF OLSON CONSTRUCTION CO., a corporation, for THE IMPROVEMENT OF TORREY PINES SCIENCE PARK - UNIT NO. 3, in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 765846.
2. That the City Auditor and Comptroller is hereby authorized to delete CIP No. 39-034 and to transfer \$50,000.00 from CIP No. 39-034, Fund 2451 to CIP No. 39-016.2, Fund 2451.
3. That the City Auditor and Comptroller is hereby authorized to transfer \$76,250.00 within Water Operating Fund 500 from the Unallocated Reserve (69.69) to Water Engineering Service (69.46).
4. That the expenditure of \$650,000.00 from Fund 2451, CIP 39-016.2 and Fund 500, of the City of San Diego is hereby authorized solely and exclusively for providing funds for said project and related costs.
5. That the City Auditor and Comptroller is hereby authorized to transfer \$23,250.00 from CIP No. 39-016.2, Fund 2451 to CIP No. 90-2451 Unallocated Reserve, 2451 Fund.
