A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SAN DIEGO, CALIFORNIA, ACCEPTING THE GRANT OFFER OF THE UNITED STATES OF AMERICA THROUGH THE FEDERAL AVIATION AGENCY TO BE USED UNDER PROJECT NO. 79-1-A-06-0211-01 FOR THE PREPARATION OF THE MASTER PLAN/LAND USE PLAN FOR MONTGOMERY FIELD.


BE IT RESOLVED, by the City Council of The City of San Diego, California, as follows:

Section 1. That The City of San Diego shall accept the Grant Offer of the United States of America in the amount of \$82,989 for the purpose of obtaining Federal Aid under Project No. 79-1-A-06-0211-01 in the preparation of the Master Plan/Land Use Plan for the Montgomery Field Airport.

Section 2. That the City Manager of The City of San Diego is hereby authorized and directed to sign the statement of Acceptance of said Grant Offer (entitled Part II - Acceptance) on behalf of The City of San Diego, and the City Clerk is hereby authorized and directed to attest the signature of the City Manager and to impress the official seal of the City of San Diego on the said statement of Acceptance.

Section 3. A true copy of the Grant Offer referred to herein is attached hereto and made a part hereof and on file in the office of the City Clerk as Document No. 766445.
