

RESOLUTION No. 223666 (R-79-2522)


Adopted on JUN 5 1979

BE IT RESOLVED, by the Council of The City of San Diego as follows:

BE IT RESOLVED, that the San Diego Unified Port District be and it is hereby urged to extend the curfew on certain landings and takeoffs as it now exists to 11:30 p.m. to 6:30 a.m.; provided, however, that any aircraft which is duly scheduled to land or take off prior to 11:30 p.m. shall be allowed a period of 15 minutes after 11:30 p.m. in which to land or take off if the delay in meeting the 11:30 p.m. deadline cannot be met due to circumstances beyond the reasonable control of the pilot or the air carrier affected thereby; and further provided that any aircraft which is duly scheduled to land or take off after 6:30 a.m. shall be allowed a period of 15 minutes prior to 6:30 a.m. in which to land or take off if the 6:30 a.m. deadline cannot be met due to circumstances beyond the reasonable control of the pilot or the air carrier affected thereby.
