

RESOLUTION NO. 223668 (R.79-2044)

WHEREAS, The City of San Diego has an ongoing Housing Rehabilitation Program; and

WHEREAS, the Housing Rehabilitation Program is funded through the Community Development Block Grant Program; and

WHEREAS, The City also is participating in the California Housing Finance Agency HO-HI Program which involves State funds for housing rehabilitation; and

WHEREAS, The City is using State funds for housing rehabilitation through the California Housing Finance Agency Title I Program; and

WHEREAS, The City desires to maximize the effectiveness of its Housing Rehabilitation Program; and

WHEREAS, the State of California has established a Deferred-Payment Rehabilitation Loan Fund, also known as SB 966; and

WHEREAS, under SB 966 the State of California is making available up to \$200,000 for local agencies for housing rehabilitation loans; and

WHEREAS, participation in the SB 966 program will not entail the expenditure of any additional City funds; and

WHEREAS, the availability of SB 966 funds will allow certain property owners to obtain property rehabilitation loans they may not have otherwise been able to obtain; NOW, THEREFORE,


BE IT RESOLVED, by the Council of The City of San Diego, that the City Manager, or his designee, is hereby authorized,
