BE IT RESOLVED, by the Council of The City of San Diego as follows:

That the City Manager be, and he is hereby authorized and empowered to execute, for and on behalf of said City, a 10-year lease agreement with POINT LOMA COLLEGE for the construction and maintenance of turf, fencing and irrigation on an existing sports field on Sunset Cliffs Park, said lease agreement is on file in the office of the City Clerk as Document No. 766775.

BE IT FURTHER RESOLVED, that the City Manager be, and he is hereby directed to indicate that the ball field is a City park by posting signs and to indicate the hours at which the college will have exclusive use.
