WHEREAS, the Congress, under Public Law 88-578, has authorized the establishment of a Federal Land and Water Conservation Fund Grant-in-Aid Program, providing matching funds to the State of California and its political subdivisions for acquiring lands and developing facilities for public outdoor recreation purposes; and

WHEREAS, the State Department of Parks and Recreation is responsible for the administration of the program within the State, setting up necessary rules and procedures governing application by local agencies under the program; and

WHEREAS, the proposed LAKE MURRAY, COWLES AND FORTUNA MOUNTAIN REGIONAL PARK PROJECT is consistent with the California Outdoor Recreation Resources Plan: and

WHEREAS, the City of San Diego and the County of San Diego has jointly undertaken the implementation of the LAKE MURRAY, COWLES AND FORTUNA MOUNTAIN REGIONAL PARK PROJECT; and

WHEREAS, acquisition of approximately 211 acres in Priority Area l of the Regional Park Project is under way and the County has conducted appraisals and can best proceed with acquisition through the transfer of the City's entitlement under the funding program; NOW, THEREFORE,

BE IT RESOLVED, by the Council of The City of San Diego, as follows:
