BE IT FURTHER RESOLVED, that the bid of TAYLOR BUS SERVICE is hereby accepted; and that the City Manager is hereby authorized to execute a contract for bus service as may be required for a period of ten (10) weeks beginning June 18, 1979 through August 24, 1979, at a total cost of \$28,922.25.
