


**RESOLUTION No. 223710** (R- 79-2414)

That the bid of \$190,210.50 by LUNATI CONSTRUCTION, INC., a corporation, for the CONSTRUCTION OF WATER MAIN REPLACEMENT GROUP 416 in the City of San Diego, California, is hereby accepted; and the City Manager is hereby authorized to execute a contract therefor in accordance with the form on file in the office of the City Clerk as Document No. 765908.
2. That the expenditure of \$272,211.00 is hereby authorized out of the Water Revenue Fund 502 of the City of San Diego solely and exclusively for the purpose of providing funds for said project and related costs.
